SECTION 4: First aid measures

4.1. Description of first aid measures

General information

When in doubt or if symptoms are observed, get medical advice.

Never give anything by mouth to an unconscious person or a person with cramps.

If unconscious place in recovery position and seek medical advice.

After inhalation

Remove casualty to fresh air and keep warm and at rest.

If breathing is irregular or stopped, administer artificial respiration.

After contact with skin

Immediately remove any contaminated clothing, shoes or stockings.

After contact with skin, wash immediately with plenty of water and soap.

After contact with eyes

In case of contact with eyes flush immediately with plenty of flowing water for 10 to 15 minutes holding eyelids apart and consult an ophthalmologist. Remove contact lenses, if present and easy to do. Continue rinsing. Seek medical advice immediately.

After ingestion

If swallowed, rinse mouth with water (only if the person is conscious).

Call a physician immediately.

Put victim at rest, cover with a blanket and keep warm.

Advice on safe handling

In case of insufficient ventilation and/or through use, explosive/highly flammable mixtures may develop. Only use the material in places where open light, fire and other flammable sources can be kept away. Use explosion-proof electrical equipment. Filling and transfer: Take precautionary measures against static discharges. Provide earthing of containers, equipment, pumps and ventilation facilities.
